
## PROTOCOL FOR DISPLAYING THE FREEDOM FLAG in REMEMBRANCE OF 9/11

The Freedom Flag may be displayed with other flags <u>as long as its display abides by the applicable protocols of those</u> <u>other flags</u>. If flown with the US Flag, the US Flag shall be in a position of prominence over the Freedom Flag and shall be flown in accordance with United States Code Title 36 Chapter 10.

## Freedom Flag Protocol – Key Elements:

- 1. The Freedom Flag should be raised each September 11th (Patriot Day) and flown through the end of September. If desired, the Freedom Flag may be flown for shorter or longer periods, including year-round. The Freedom Flag may be displayed outdoors or indoors.
- 2. When raised in remembrance of Sept. 11, 2001, the 10 elements of the Freedom Flag should be read after the Freedom Flag has been raised, and a moment of silence shall follow.
- 3. The top of the white star should point up when flown horizontally or right when displayed vertically (i.e., on a wall). When displayed horizontally or vertically on a wall, the blue field should be to the left or top (respectively).
- 4. The Freedom Flag should not overshadow the US Flag or any other flag of national or state significance in any way. When displayed with other flags of significance, the size of the Freedom Flag should be smaller than the other flags or relatively equal to the size of the smallest flag.

This protocol for displaying the Freedom Flag has been prepared to provide uniform institutional guidance to schools, fire stations, and government buildings, along with the general public on when and how to fly the Freedom Flag. In preparing this protocol, the Freedom Flag Foundation seeks to respect fully the existing protocols for flying the US Flag, all state flags, and other official flags. The Freedom Flag has been flown in <u>all 50 states</u> – including at nearly 2,000 schools – as a symbol of remembrance for 9/11. It stands as our nation's only codified flag of remembrance for September 11, 2001 (Virginia / VAC §1-510 | Oklahoma / O.S. Title 25 §93.3 | Delaware / 29 Del. C. §331). The Freedom Flag's symbolism invokes a solemn remembrance of the events of that day and of the 2,977 lives which were lost. On 9/11/2001 we were reminded that *freedom is not free*. Appropriate display of the Freedom Flag helps ensure that we uphold the promise we made as Americans to NEVER FORGET those who lost their lives, and those who responded heroically on that fateful day.
